# Minutes of the Council Meeting held on 17<sup>th</sup> November 2010 in the Council Chamber, Bridlington Town Hall

Present: Councillors P Austin, L Chambers, M Charlesworth, T Dixon, S Finlay, J Foster, G Holmes, S Marsburg and D Metcalf (9). Also in attendance were six (6) members of the public, including East Riding of Yorkshire Councillor Matthews.

Mrs Paula King, Interim Town Clerk & Civic Officer recorded the minutes.

#### 135/10 Mayor's welcome:

The Mayor took a moment to convey, "The Town was shocked by the fire which killed three young children last week, and our thoughts are with their mother Samantha and we all hope that she makes a full recovery. The children made a lasting impression and will be greatly missed by their school friends. I am sure that the community will pull together through this tragic event and help and support Samantha and her family in the days and weeks to come". The Mayor then welcomed everyone to the meeting.

recent tragedy in Bridlington and that it was very well supported considering the amount of people at the event. Mr Felton enquired about civic dinner costs and budgeting and was informed by the Mayor that as long as the all the civic costs fall within the civic budget that was

#### 144/10 Adizone Facility - Cllr Austin:

Cllr Austin informed the Council of issues that the residents of North Ward have raised regarding the Adizone facility. The first that it is not clear that the school does not own the facility and that access is not via the school and that signage would potentially alleviate this situation. Rubbish is regularly seen blowing around the field area due to that fact that the Adizone does not have any litter bins. Provision of a litter bins would help to alleviate this problem.

**RESOLVED**: To contact the ERYC to request that both issues are addressed but Cllr C Matthews was present

at the meeting and the Mayor asked if he would be able to address the matters raised with the area being his Ward and Cllr Matthews agreed to report both matters to the East Riding of

Yorkshire Council.

#### 145/10 Bridlington Town Council's Boundary Review Plan – Cllr Charlesworth:

Cllr Charlesworth provided details of electorate in Bridlington and surrounding areas to show how Bridlington under represented. He went on to deliver a way in which the Council could aim to change the number of representative councillors and a boundary review due to the changes of numbers in Ward Areas of Bridlington.

**RESOLVED:** The Bridlington Town Council made a unanimous decision to initially petition for an increase

to a number of 19 councillors in Bridlington and to follow this petition up with a boundary

review. All details to be considered at the Council meeting in December.

#### 146/10 Area Action Plan (AAP) collation of points from Bridlington Town Council:

The Council noted the time extension for the AAP from the East Riding of Yorkshire Council to the 10<sup>th</sup> January 2011. The Council noted the points from Mr Guildford and the WASSARG.

points have been properly addressed and the extra items completely integrated with the time

extension affording a more in-depth analysis to take place.

# 147/10 Harbour Toilet Report – Cllr Finlay:

The Mayor informed of her, no cost to the public, visit to the toilets situated on the Harbour in Bridlington at the request of Mrs Dunn. Cllr Finlay reported that the overall view was that they were not very different to any other

toilets she had used and that they would most likely benefit from a deep clean paying attention to the walled areas.

**RESOLVED:** To contact the Harbour Master's Office and Mrs Dunn and convey the findings.

#### **148/10** CCTV in Bridlington – Cllr Holmes:

Cllr Holmes thanked Mrs King for arranging the visit to the CCTV department and wished to also convey thanks to Mr Sykes and he then reported the following:

"Due to the level of crime in Bridlington I was interested to look at CCTV in the area and at how effective this is. We recently paid an interesting and impressive visit to the Resource Centre on Victoria Road where the cameras are monitored. There are 40 cameras in town all of which record and are monitored constantly throughout any 24 hour period. Police presence in Bridlington would appear to be relatively low and there is therefore reliance on CCTV. Interestingly in the last 12 months 130 crimes per month have been detected by CCTV leading to 30 - 50 arrests per month. There are areas of the town without any coverage and therefore there is a need for more cameras. There are plans for more cameras although obviously more funding is required".

At present the ERYC will be undertaking a CCTV review. There were also more members of Bridlington Town Council would like to visit the CCTV department. Cllr Holmes enquired as to the possibility of the Bridlington Town Council being able to provide more funding towards CCTV in the town bearing, in mind that it pays for 50% towards the costs of funding at present.

- 2. To place CCTV item onto the January Finance and General Purposes Committee Agenda.

- 4. To ask Mr Sykes to arrange another visit for other Bridlington Town Councillors to attend.
- 5. To request a copy of the CCTV review report that the ERYC is currently compiling.
